

Registration Procedures (rev. 1/2026)

1. Register yourself online at HawaiiCouncil.org

HCCA or the Managing agents (CAM) are not responsible for email typo's.

The registration is your obligation and commitment to the HCCA registration fee to include applicable late fee payment.

Payment/s is required in advance.

If Payment/s not received within 15 days of the invoice date, it will be subject to a \$25.00 late fee.

2. HCCA will formally invoice your Association Managing Agent (CAM) for your registration.
3. They are responsible to process your payment and is Due prior to the seminar date.

514B-107 (f)

The directors may expend association funds, which shall not be deemed to be compensation to the directors, to educate and train themselves in subject areas directly related to their duties and responsibilities as directors; provided that the approved annual operating budget shall include these expenses as separate line items.

5. Industry businesses are encouraged to attend. Payment must be received prior to the seminar date. No exceptions.
6. Unit owners are encouraged to attend. Payment is required from your own funds.
