

Registration Procedures (2/2023)

1. Register yourself online at HawaiiCouncil.org & Mark the date on your Calendars.

Please plan accordingly, as no reminders will be sent.

HCCA or the Managing agents are not responsible for email typo's.

The registration is your obligation and commitment to the HCCA registration fee to include applicable late fee payment.

Payment/s is required in advance.

If Payment/s not received within 30 days after the online registration date, it shall be subject to a \$25.00 late fee.

2. The invoice will be sent to your Managing Agent to process payment for Board Members only.

514B-107 (f)

The directors may expend association funds, which shall not be deemed to be compensation to the directors, to educate and train themselves in subject areas directly related to their duties and responsibilities as directors, provided that the approved annual operating budget shall include these expenses as separate line items.

3. **Association Employees** are encouraged to attend. If the Board is paying for the registration fee, it is recommended to have Board approval and recorded in the meeting minutes.

Purpose of the Town Hall

This Town Hall is intended to provide an opportunity for condominium owners, board members, and legislators to engage in a **civil, nonpartisan, and informational dialogue** on issues affecting condominium communities and housing in Hawai'i.

Respectful Conduct and Decorum

- All participants shall conduct themselves with decorum, professionalism, and mutual respect.
- Disruptive behavior, shouting, personal attacks, or inflammatory language will not be permitted.
- Derogatory, defamatory, or disrespectful comments about any individual, elected official, political office, or organization are prohibited.
- The moderator's instructions and rulings shall be respected at all times.
- Speaking Time Limits will be established prior to the start of the Townhall to ensure all voices have an opportunity to be heard.
- Responses by panelists or legislators may also be time-limited at the discretion of the moderator.
- Not Permitted: Interruptions while others are speaking.
- Use of signs, props or displays that detract from the forum.

- Questions may be submitted **in advance** to HCCA@HawaiiCouncil.org and **in person** during the event.
- The moderator will select and sequence questions to promote a balanced discussion and efficient use of time.
- Participants must be recognized by the moderator before speaking.
- Follow-up questions may be limited to allow equitable participation
